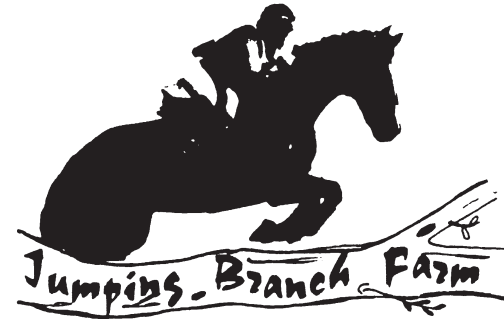

Sunday, Feb. 26 Open Schooling

- Directions: From I-20 (Exit 22 Hwy 1 south to Rt. 78), turn left (East). Follow Rt. 78 approx. 5 mi. to Montmorenci. Turn left on Montmorenci Rd. (at Annie's Inn).
- Follow to second right (Fox Pond Rd.). Jumping Branch Farm is the first driveway on the left. More directions at JBFarm.com

Classes

1. **Open Preliminary** } Fences to 3'7" - Speed 520 mpm
 } Dressage - Prelim Test A
2. **Open Training** } Fences to 3'3" Speed 450 mpm
3. **Training Rider** } Dressage - Training Test A
4. **Open Novice** } Fences to 2'11" Speed 375 mpm
5. **Novice Rider** } Dressage - Novice Test A
6. **Beg. Novice Rider** } Fences to 2'7" Speed 350 mpm
7. **Open Beg. Novice** } Dressage - Beg. Novice Test B
8. **Tadpole** } Fences to 2' * Speed 300 mpm
 } Dressage - Beg. Novice Test B

**Only 5 X-C mandatory fences, all other BN jumps optional.*

- X-C Course closes Feb. 12th at midnight.
 - 12 month Coggins required on all participants, send with entry.
 - Organizer may divide or combine classes as entries warrant.
 - 10 Stalls on grounds, 100 stalls 3 miles away at Full Gallop Farm
 - Stalls \$25.00 per night, includes bedding.
 - \$15.00 **Separate** Stall Cleaning Deposit, *send with entry* - will be destroyed if stall cleaned very well.
 - Hard hats must be worn at all times when mounted.
 - Hard hats with a harness required at all times when jumping.
 - Medical armbands are required for all jumping. (Can be homemade)
 - All tests in small arenas. Entries limited to 150.
 - Braiding and coats not required
 - State age and level of experience on entry.
 - No rain date or entry refund - free x/c schooling in future.
 - Times available on web page - www.jbfarm.com
 - Scratch refunds allowed before Feb. 13 Midnight. Must be faxed, or e-mailed, (*no answering machine scratches*) less \$15 office fee-after Feb. 13.
- Only if space filled by waiting list.
